ORDINANCE NO. 555

AN ORDINANCE APPROVING A  
MUNICIPAL COOPERATION AGREEMENT BETWEEN THE  
BOROUGH OF LIGONIER AND THE COUNTY OF WESTMORELAND  
FOR GOVERNMENTAL SERVICES

WHEREAS, 53 Pa. C.S.A. §2303 authorizes two or more local governments to jointly cooperate with any similar entities in the exercise or in the performance of their respective governmental functions, powers or responsibilities; and

WHEREAS, 53 Pa. C.S.A §2305 provides that a local government may enter into intergovernmental cooperation with another local government unit upon the passage of an ordinance by its governing body.

BE IT ORDAINED, and it is hereby enacted and ordained by the Council of the Borough of Ligonier in session lawfully assembled as follows:

SECTION I

The Council of the Borough of Ligonier (hereinafter called "Borough") and the Board of Commissioners of the County of Westmoreland (hereinafter called "County") have agreed to enter into a Municipal Cooperation Agreement providing for the County to have the inspectors from the Westmoreland County Department of Weights and Measures perform the parking meter inspections for the Borough under the provisions of 53 Pa. C.S.A. §2301 et. seq.

SECTION II

The term of the Municipal Cooperation Agreement shall be until December 31, 2017, with an option to renew for an additional five (5) years, with the condition that either Borough or County may terminate said Agreement by providing the other party with ninety (90) days' notice prior to the intended termination date.

SECTION III

Borough authorizes County to perform required parking meter inspections on its behalf.

SECTION IV

There is no financing involved with the Municipal Cooperation Agreement.

SECTION V

There is no additional organizational structure necessary to implement the Agreement.

SECTION VI

There is no real or personal property being acquired, managed, licensed or disposed of by the Municipal Cooperation Agreement, except for the Annual Device License for all parking meters issued by the County Department of Weights and Measures.

SECTION VII

There is no new entity being created by the Municipal Cooperation Agreement.

SECTION VIII

The Municipal Cooperation Agreement shall become effective when adopted by Ordinance by both Borough and County.


SECTION IX

This Ordinance shall become effective upon passage.


